Additionally, the system is equipped with a safety exit button, ensuring a safe and controlled environment for all users.



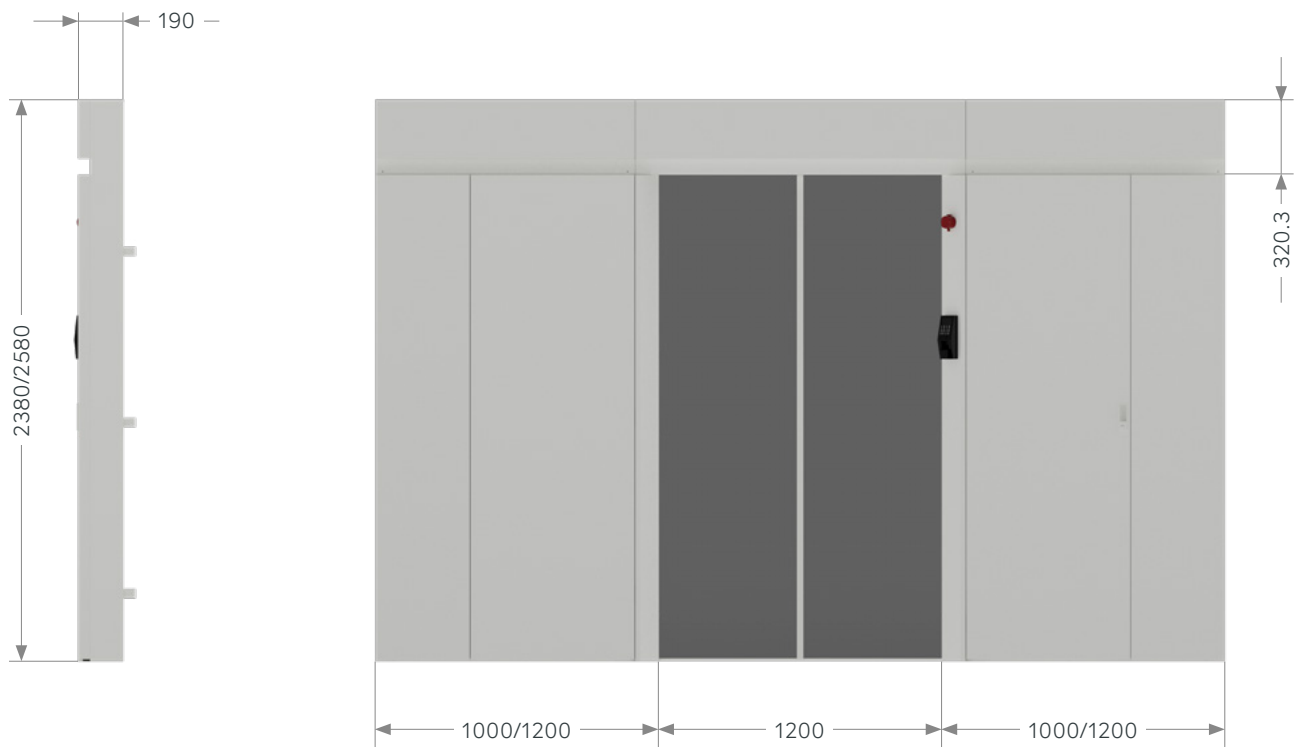
For added safety, two infrared sensor beams are installed, preventing door closure while motion is detected near the doors. This ensures a secure environment and minimizes the risk of accidents.

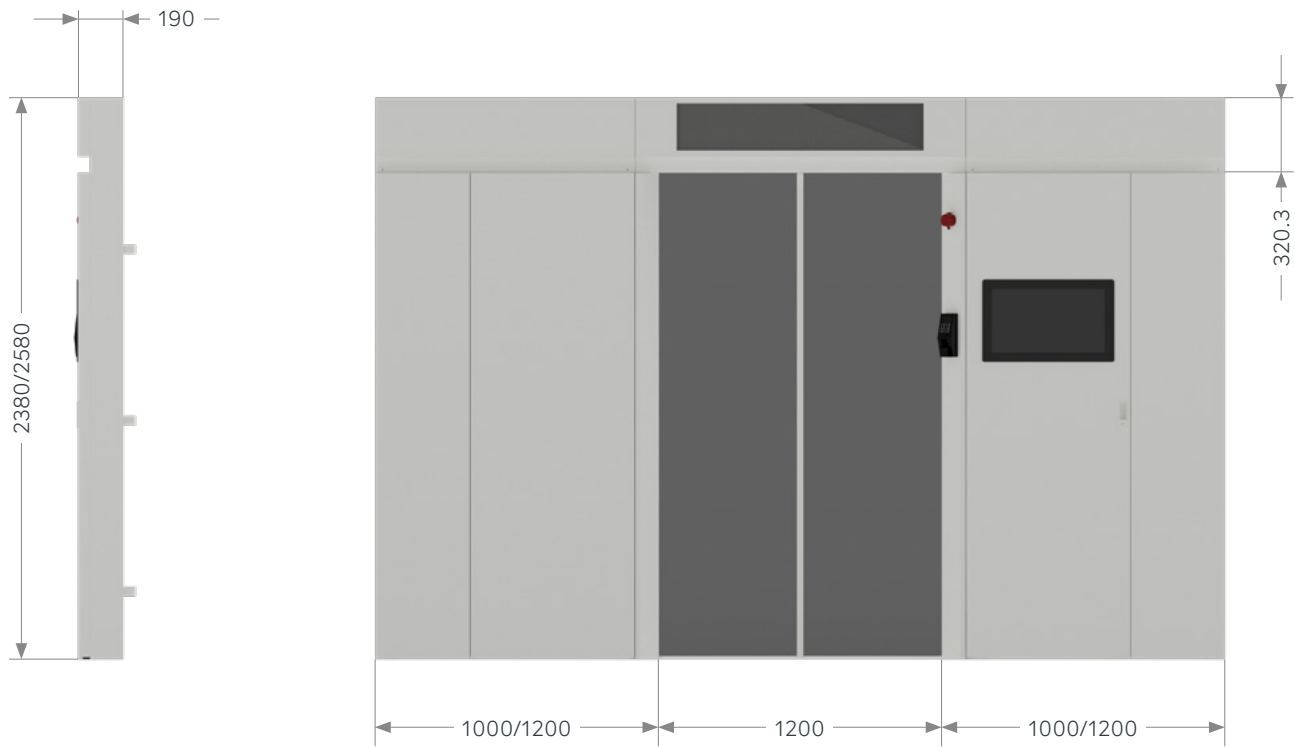

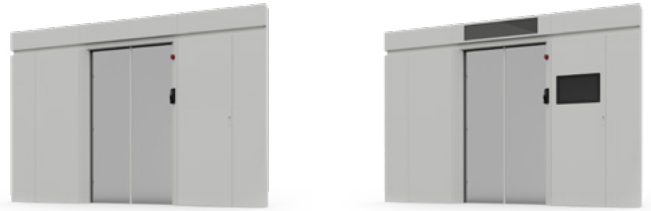
Double Row Sliding Door with Monitoring System LCD
